

TERMS OF USE

SOCIALAB.COM

Socialab.com is a website created to post open innovation challenges and to promote their solutions through innovative ideas with social impact. Through this website our users can upload their ideas or projects, comment on other publications, vote their favorite ideas and learn about the challenges of companies and organizations around the world.

When we talk about “socialab.com” we mean both the main domain “socialab.com”, as well as all other sub-domains hosted in it, such as “comunidad.socialab.com”, “backoffice.socialab.com”, “bootcamp.socialab.com”, among others. Both our main domain and the existing sub-domains, as well as any other domains that we might create in the future, are governed by these Terms of Use and our Privacy Policy.

Please read carefully these Terms of Use before entering or logging in “socialab.com”. To access and/or use our website you must accept these Terms of Use, this acceptance means a legal and contractual bond between you and Socialab.

Along these Terms of Use, we have established a Privacy Policy that explains what kind of user information we collect, how we use it, protect it and under which circumstances we are allowed to share it with third parties. We highly recommend our users to read carefully our Privacy Policy as well as these Terms of Use.

It is possible that from time to time we may modify these Terms of Use. If we decide to do so, the updated version will be promptly published and uploaded in our website. Depending on the circumstances we may also send you communications via e-mail. The new versions of these Terms of Use will never be applied in a retroactive way and you will be informed in a timely manner of their effective date. If after the modification or update of these Terms of Use you continue to make use of the platform “socialab.com”, you are deemed to have accepted the new Terms of Use.

1. ACCESS TO SOCIALAB.COM

Account

Navigating through “socialab.com” is free of charge and doesn’t require registration or creation of an account, but to access to some of the website’s features you may have to register, create a user name and set a secure password. The information you provide during this process must be true and complete. Do not impersonate another person and do not

choose offensive names or names that may affect third parties' rights. If you do not comply to these norms, we reserve the right to cancel your account.

By using "socialab.com" you agree to abide to all state and local laws, including, without limitation, the current laws on Industrial and Intellectual Property.

Security

You are responsible for your account's activity and for the safekeeping of the confidentiality of your password. By accessing "socialab.com" you agree to provide truthful and accurate information. We suggest you to take all the necessary measures for the safekeep of your account, including the use of a secure password. When using "socialab.com" you agree to not execute any of the following actions regarding your account:

- a) To commercialize in any way your user name, account and password.
- b) To access or try to access third parties' accounts without their authorization.
- c) To create multiple accounts or a new account after the disabling or banning of your original account by "socialab.com".

If you find out another person have used or is using your account without your authorization you may denounce him/her by sending an e-mail to support@socialab.com

To create an account you must be at least 13 (thirteen) years old or the legal age to conclude a valid contract in your place of residence. If we deem it necessary, we may request you proof of your age. For further information on this topic we recommend you to read our Privacy Policy's section "Under Age Users".

You will always be able to eliminate your account in any time and for any reason. To do so you must send an email to support@socialab.com, requesting the immediate elimination of your account.

2. USE OF THE SOCIALAB.COM PLATFORM

One of our main goals is to provide you and our other users of the platform a respectful and safe environment. In order to accomplish that goal, and unless stated differently in these Terms of Use, you shall not execute any of the following activities:

- Do not take any activity that infringe or violate other persons rights or that infringe the law or any contract or legal duty you may have with anyone.

- Do not delete, alter, cover, or misrepresent the copyright, trademark, patent or any other property rights on the website or on the web content.
- Do not take any activity that may be interpreted as threatening, abusive, harassing, defamatory, libelous, malicious, offensive, profane or invasive to the privacy of someone else. - Do not interfere with the proper functioning of the services, nor avoid the measures put in place by us to protect the services.

3. RIGHTS

Rights of “socialab.com”

“socialab.com” shall have the right to close your account at any time, specially if it is being misused, either by infringing any of the prohibitions or limitations stated in these Terms of Use or by any other reason we deem go against other users’, third parties or our rights. We also have the right to refuse, cancel, interrupt remove or suspend any content published on the platform. “socialab.com” does not take any kind liability for any damage caused by these actions. “socialab.com” has no obligation to make any kind of clarification regarding the reasons behind any of these measures.

On the other hand, “socialab.com” may execute changes of any nature on the platform without having any obligation or duty to seek approval or authorization from its users, nor to give prior notice of such changes.

Intellectual property of Socialab
